- **Move your polling place to your living room.** Request your ballot by contacting the Supervisor of Elections office via telephone, email, mail, in person or by visiting our website. Vote-by-mail ballots must be returned to the Supervisor of Elections Office by 7 pm on Election Day in order to be counted.
- **Early voting** will be held Monday, March 1 – Friday, March 5, 2021, at the Supervisor of Elections Offices in Crestview and Shalimar. Hours of operation are 8:30 am – 4:30 pm.
- Your polling places (see reverse) for registered city residents will be open from 7 am to 7 pm on March 9, 2021, Election Day.
