

OKALOOSA COUNTY POLL WORKER APPLICATION

Active duty military members may serve as poll workers if the Secretary of the branch of service in which the member serves has given prior approval. (DOD Directive 1344.10)

NOTE: PLEASE READ JOB REQUIREMENTS BEFORE COMPLETING APPLICATION.

All poll workers must meet the following requirements:

- ✓ Must be a registered voter in Okaloosa County;
- ✓ Must be able to read, write, and speak the English language and direct voters through the voting process;
- ✓ Must be able to attend a training session prior to each election (F.S. 102.014(1));
- ✓ Must have your own transportation to and from the polling place and the training classes;
- ✓ Must be able to work at least 14.5 hours on election day and remain at the polling place until dismissed by the Clerk;
- ✓ Must have the ability to sustain long periods of sitting and/or standing throughout the day, **dependent of position assigned**;
- ✓ Must be able to lift 30 pounds;
- ✓ Must be able to abstain from smoking on election day; and
- ✓ Must have the ability to deal with the public in a courteous, patient and efficient manner.
